Slough of Spokane Falls of the County of Spokane in the Territory of Washington grantee part y of the second part: WITNESSETH, that the said part y of the first part, for and in consideration of the sum of fifty Dollars, to him paid by the said part y of the second part, the receipt whereof is hereby acknowledged, do ES by these presents, GRANT, BARGAIN AND SELL, CONVEY AND CONFIRM, unto the said part y of the second part and his heirs and assigns, the following described lots, tracts or parcels of land, lying and situate in the County of Kittitas and State of Washington, to-wit: all

of Lot seventeen (17) in Block six (6) in Haley's Addition to the Town of Wenatchee as recorded on plat, in the office of the County Auditor of Kittitas County Wash. Ter.

TO HAVE AND TO HOLD, the premises aforesaid, with all and singular the rights, privileges, appurtenances, and immunities thereunto belonging, or in anywise appertaining, unto the said part y of the second part, and unto his heirs and assigns, forever; the said Edward A. Haley hereby covenanting that he is lawfully seized of an indefeasible estate in fee, in the premises herein conveyed; that he has good right to convey the same; that the said premises are free and clear of any incumbrances done or suffered by him or those under whom he claims; and that he will WARRANT AND DEFEND the title to the said premises unto the said part y of the second part, and unto his heirs and assigns, FOREVER, against the lawful claims and demands of all persons whomsoever.
